

## Local Councils, Internal Drainage Boards and other Smaller Authorities in England Annual return for the year ended 31 March 2016

Every smaller authority in England with an annual turnover of £6.5 million or less must complete an annual return at the end of each financial year in accordance with proper practices summarising its activities. In this annual return the term 'smaller authority'\* includes a Parish Meeting, a Parish Council, a Town Council and an Internal Drainage Board.

#### The annual return on pages 2 to 4 is made up of three sections:

- Sections 1 and 2 are completed by the smaller authority. Smaller authorities must approve Section 1 before Section 2.
- Section 3 is completed by the external auditor.

In addition, the internal audit report is completed by the smaller authority's internal audit provider.

Each smaller authority must approve Sections 1 and 2 of this annual return no later than 30 June 2016.

#### Completing your annual return

Guidance notes, including a completion checklist, are provided on page 6 and at relevant points in the annual return.

Complete all highlighted sections. Do not leave any highlighted box blank. Incomplete or incorrect returns require additional external auditor work and may incur additional costs.

Send the annual return, together with the bank reconciliation as at 31 March 2016, an explanation of any significant year on year variances in the accounting statements, **your notification of the commencement date of the period for the exercise of public rights** and any additional information requested, to your external auditor by the due date.

Your external auditor will ask for any additional documents needed for their work. Unless requested, do not send any original financial records to the external auditor.

Once the external auditor has completed their work, certified annual returns will be returned to the smaller authority for publication or public display of Sections 1, 2 and 3. You must publish or display the annual return, including the external auditor's report, by 30 September 2016.

It should not be necessary for you to contact the external auditor for guidance.

#### Matters reported

#### Accounting for Fixed Assets, Section 2

We reported in our 2014/15 audit report that Box 9 of Section 2 of the Annual Return – the Accounting Statements includes fixed assets that have been devalued. Some assets had been written down from a value of £6,875 to a nominal value of £1.

The 2014/15 figure of Box 9 of Section 2 of the Annual Return again includes fixed assets that are valued at a nominal value of £1.

The figure should have been restated following the other matters noted in last year's external auditor's report. The council should have written 'restated' beneath the '£' symbol of the 2015 column before the Annual Return is made available to the public.

# Order of signing the Annual governance statement (Section 1) and the Accounting statements (Section 2)

The Parish Council has considered, approved and signed the Annual Governance Statement (Section 1) as minute reference 620 and the Accounting Statements (Section 2) as minute reference 617 on the same day. This appears to be in the wrong order and the Parish Council was not able to provide any evidence that it had been considered in the right order. The Accounts and Audit Regulations 2015 stipulate that the Annual Governance Statement must be considered, approved and signed before the Accounting statements at Section 2 by resolution of members of the authority meeting as a whole. In future, the Parish Council should ensure that the minute references clearly demonstrate that that the Annual Governance Statement was considered, approved and signed before the Accounting statements.

#### Internal Auditor's Report

The internal auditor's report sent to the external auditors was not factually correct. The internal auditor answered No to objective I. The correct response is Yes.

The council should ensure that the internal auditor's report is reviewed before sending the document to the external auditors. The council should minute this process. If there are any errors in the report it should either be amended or the council should provide an explanation for the error.

Additionally, in future the Council should ensure bank reconciliations are regularly reviewed and approved at full council meetings.

#### Accounting for Fixed Assets, Section 2

It has come to our attention that Box 9 of Section 2 of the Annual Return – the Accounting Statements includes a fixed asset, village car park, valued at a rateable value and a 'village lock up' that has not been given a value. .

Accounting for fixed assets which have been 'transferred' to the parish council should be given a proxy value of a £1. Guidance on accounting for fixed assets of this nature is available in NALC/SLCC publication "Governance and Accountability for Local Councils – A Practitioners Guide (England)" paragraph 3.76.

The Practitioners Guide strongly recommends that assets that are 'community assets' that have no functional purpose or any intrinsic resale value (for example, a village pond or a village green) are disclosed in Section 2, Box 9 of the Annual Return at £1 as a proxy for the zero cost.

## Guidance notes on completing the 2015/16 annual return

- 1. You must apply proper practices for preparing this annual return. Proper practices are found in the Practitioners' Guide\* which is updated from time to time and contains everything you should need to prepare successfully for your financial year-end and the subsequent work by the auditor. NALC, SLCC and ADA have helplines if you want to talk through any problem you encounter.
- 2. Make sure that your annual return is complete (i.e. no empty highlighted boxes), and is properly signed and dated. Avoid making amendments to the completed return. Any amendments must be approved by the smaller authority, properly initialled and explanation provided. Annual returns containing unapproved or unexplained amendments will be returned and may incur additional costs. Smaller authorities must approve the annual governance statement before approving the accounts.
- 3. Use the checklist provided below. Use a second pair of eyes, perhaps a Councillor or Board Member, to review the annual return for completeness before sending it to the external auditor.
- 4. Do not send the external auditor any information not specifically asked for. Doing so is not helpful. However, you must tell the external auditor about any change of Clerk, Responsible Finance Officer or Chair.
- 5. Make sure that the copy of the bank reconciliation which you send to your external auditor with the annual return covers all your bank accounts. If your smaller authority holds any short-term investments, note their value on the bank reconciliation. The external auditor must be able to agree your bank reconciliation to Box 8 on the accounting statements (Section 2 on page 3). You must provide an explanation for any difference between Box 7 and Box 8. More help on bank reconciliation is available in the Practitioners' Guide\*.
- 6. Explain fully significant variances in the accounting statements on **page 3**. Do not just send in a copy of your detailed accounting records instead of this explanation. The external auditor wants to know that you understand the reasons for all variances. Include complete analysis to support your explanation. There are a number of examples provided in the Practitioners' Guide\* to assist you.
- 7. If the external auditor has to review unsolicited information, or receives an incomplete bank reconciliation, or you do not fully explain variances, this may incur additional costs for which the auditor will make a charge. From 2016 onwards, you must inform the auditor of the date set for the commencement of the period for the exercise of public rights.
- 8. Make sure that your accounting statements add up and the balance carried forward from the previous year (Box 7 of 2015) equals the balance brought forward in the current year (Box 1 of 2016).
- 9. Do not complete Section 3 which is reserved for the external auditor.
