CLERK'S REPORT - 14th May 2024

Standard Annual Parish Council Meeting Matters – Agenda Items 1- 10

All of these items proceed in the normal manner, as usual, led by the Clerk.

Review and Adoption of Parish Documents – There will be revised documents to approve and adopt following comments in the Internal Auditors report.

Parish Council Matters – Agenda Item 11

EA/2022/0254; Monkton Combe Parish Council vs Information Commissioner (ICO Case Reference: IC-160435-H5M4). – The Clerk reports that the Appeal was eventually dismissed, and that he has now provided Oldfield RFC Ltd. (Mr. Patrick Bunton) with the information requested, but with all personal information redacted, so that other than the Chair and the Clerk the correspondents are not identified and their personal data is not disclosed.

The appeal was dismissed on the three grounds presented.

- 1. That the Information Commissioner used his discretion in determining the case and issued the decision notice without further correspondence with the Parish Council. *The Tribunal was of the view that this was not a valid ground of appeal as it relates to the conduct of the First Respondent's investigation, oversight of which is not within the jurisdiction of the Tribunal.*
- 2. The Appellant considers that the request is not for environmental information and that it should be handled under section 14 FOIA. there is no material difference between a request that is vexatious under section 14(1) FOIA and a request that is manifestly unreasonable on vexatious grounds under the EIR. The correct regime is the EIR as the request stems from discussions of the planning application.
- 3. The Tribunal, whilst considering the Appellants points made in its grounds of appeal looked more widely to the reasons given in its refusal letter and submissions made, and tested this against the threshold test for a request being "manifestly unreasonable" under the EIR *In the Tribunal's view the Appellant has touched on some of the core issues set out in Dransfield when justifying its refusal notice dated 14 February 2022. However, it has not provided enough evidence to satisfy the high bar to show that the Request is dis proportionate and therefore manifestly unreasonable under regulation 12(4)(b) EIR.*

Parish Sweeper – Employing a new Parish Sweeper remains outstanding. Clarification of the work to be carried out is needed as the previous Sweeper carried out several tasks with a Grass Strimmer which would fall under the Footpath Vegetation Clearance Agency Agreement, and the cutting of verges which is the responsibility of B&NES Highways (although they don't and won't actually do it).
